Dear Mr. Elstein:

On October 12, 2018, the North American Electric Reliability Corporation (NERC) filed a petition seeking approval of a revision to the Implementation Plans for Reliability Standards MOD-026-1 (Verification of Models and Data for Generator Excitation Control System or Plant Volt/Var Control Functions) and MOD-027-1 (Verification of Models and Data for Turbine/Governor and Load Control or Active Power/Frequency Control Functions). Reliability Standards MOD-026-1 and MOD-027-1 were approved in Order No. 796.¹ NERC states that the Implementations Plans for both MOD-026-1 and MOD-027-1 erroneously reference “verification date” instead of “transmittal date” to set the periodicity for reverification under each standard.²

NERC’s filed petition was noticed on October 25, 2018, with interventions, comments and protests due on or before November 15, 2018. Southern California Edison filed a timely motion to intervene, raising no issues.

NERC's uncontested filing is hereby approved pursuant to the relevant authority delegated to the Director, Office of Electric Reliability under 18 C.F.R. § 375.303 (2018), effective as of the date of this order.

Such action shall not be deemed as recognition of any claimed right or obligation associated therewith and such action is without prejudice to any findings or orders that have been or may hereafter be made by the Commission in any proceeding now pending or hereafter instituted by or against the Electric Reliability Organization or any Regional Entity.

This order constitutes final agency action. Requests for rehearing by the Commission may be filed within 30 days of the date of issuance of this order, pursuant to 18 C.F.R. § 385.713 (2018)
