Margaret (Meg) Albright is a registered Professional Engineer and Project Management Professional with 30+ years of electrical utility experience. She has worked in Test & Energization, Design, Planning, Project Management, and Operations. She is the co-chair of the WECC Reliability Risk Committee and recently completed her work on the WECC Extreme Natural Events Task Force. She held the NERC Operating Committee member seat for Federal PMAs in 2018 & 2019, and is presently a member of the NERC Large Load Task Force.

Meg has extensive leadership and technical experience identifying strategic goals and prioritizing risks to reliability through her work on WECC's Western Interconnection Risk Register and BPA's Grid Modernization and Emerging Markets efforts. She has navigated her organization through the implementation of the Energy Imbalance Market, the transition to a new Reliability Coordinator, and the creation of two teams: the Real Time Study Engineer group and the Short Term Available Transfer Capability (ATC) group. Meg also was part of the core group that stood up BPA's Public Safety Power Shutoff Program in response to increasing wildfire activity in the West. In her current position as BPA's Advisor on Regional & National Reliability Initiatives, she is leading efforts to engage with NERC, WECC, ESIG and other industry groups to address the unprecedented changes impacting the adequacy and reliability of the bulk power system.
