Briefly describe the nominee's experience and qualifications to serve on the RISC:

I serve as Vice President and Chief Compliance Officer of Dominion Energy, a utility holding company headquartered in Richmond, VA. As of December 31, 2022, Dominion Energy's portfolio of assets includes approximately 31.0 GW of electric generating capacity, 10,600 miles of electric transmission lines, 78,500 miles of electric distribution lines and 93,500 miles of gas distribution mains and related service facilities, which are supported by 4,000 miles of gas transmission, gathering and storage pipeline. As of December 31, 2022, Dominion Energy operates in 15 states and serves approximately 7 million customers.

I am a graduate of the University of Virginia and the University of Michigan Law School and, prior to working for Dominion Energy, practiced law at Latham & Watkins, LLP, a global law firm, and worked for Alliant Energy, in Madison, WI, providing legal support for renewable energy infrastructure development.

Since joining Dominion Energy in 2006, I have served in leadership and executive roles in Law, Enterprise Risk Management, Supply Chain, Governance, Sustainability and, now, Compliance. In addition to currently leading Dominion Energy's Regulatory Compliance team, I also lead the company's NERC Enterprise Policy & Compliance and Electric Market Policy organizations. Together, these experiences have provided me with a deep understanding of the challenges associated with maintaining grid reliability and security while supporting electrification and load growth and deploying the low- and zero-carbon technologies required to advance the clean energy transition.

My work experience aligns closely with the RISC's areas of responsibility:

• Through my leadership of the NERC Enterprise Policy & Compliance (NEPC) organization, I have developed direct knowledge of the NERC Reliability Standards, NERC's policy priorities, ERO governance and stakeholder engagement, the reliability impact of technologies such as inverter-based resources, Dominion Energy's physical and cyber security threat environment and our associated safeguards for critical energy infrastructure and systems. • My experience leading the operations of our Enterprise Risk Management function allowed me to explore a breadth of strategic, operational, financial and regulatory risks affecting the energy industry and associated mitigating strategies. Through this role, I also developed a deep appreciation for the value of risk-informed analysis and decision making.

• All my executive and other leadership experiences have promoted my ability to navigate complex issues, communicate effectively, collaborate with stakeholders and lead through periods of change.
