# Meeting Minutes Project Management and Oversight Subcommittee (PMOS)

January 21, 2025 | 2:00 – 4:00 p.m. Eastern

### **Introduction and Chair's Remarks**

Chair M. Brytowski called the meeting to order at 2:32 p.m., Eastern. The meeting was announced and publicly posted on the <u>www.nerc.com</u> website. The Chair provided the subcommittee with opening remarks and welcomed members<sup>1</sup> and guests. Attendance was taken at the meeting. See Attachment 1 for those in attendance.

# NERC Antitrust Compliance Guidelines, Participant Conduct Policy and Public Announcement

The NERC Antitrust Compliance Guidelines, NERC Participant Conduct Policy, and the Public Announcement were presented and reviewed by J. Snider. The full antitrust guideline, participant conduct policy and public announcement were provided in the agenda package to each member via email and posted on the PMOS webpage.

# Agenda Items

#### 1. Consent Agenda and Meeting Minutes

a. The meeting agenda and previous meeting summary were reviewed. S. Habriga moved to accept the agenda and meeting minutes. C. Fritz seconded the motion. All members present voted affirmatively.

### 2. Project Tracking Spreadsheet Review (Critical projects, High priority projects)

The group discussed Critical Priority projects:

a. 2023-06 - CIP-014 Risk Assessment Refinement

C. Fritz informed the group that the DT had made changes to the draft based on the results of the recent 2<sup>nd</sup> ballot, with those changes focusing on being less prescriptive while still meeting the requirements of the SAR. Language was expected to be posted in late February or early March.

b. 2024-03 – Extreme Cold Weather Revisions to EOP-012-2:

R. Shu stated that the second ballot was not approved, receiving only 44% affirmative votes. With the March FERC filing deadline approaching, a special Board meeting was held, and the Board opted to invoke Section 321.5. A small group of SC members were reviewing the draft and the comments received. The group made revisions based on the comments, focusing on meeting the directives in FERC order. The work on revisions was nearly complete, with a 45-day posting

of comments expected to take place soon. The language would then be presented to the Board on February 20, 2025.

Next the group reviewed the 901 Milestone 3 projects:

a. Review of Workshop

M. Brytowski shared that the Milestone 3 workshop had taken place the week prior, with much being accomplished.

- b. 2022-02 Uniform Modeling Framework for IBR
   T. Pyle provided an update, noting that the DT was meeting twice a week, and had scheduled an in-person meeting for February. The DT was expecting to conduct the initial posting in mid-April.
- c. 2020-06b Verifications of Models and Data for Generators
   S. Habriga stated that the DT was meeting weekly, working on a draft. Definitions had been drafted and were anticipated to be posted after the February SC meeting. The DT was also performing a gap analysis of the drafted language compared to the FERC directives.
- d. 2021-01 System Model Validation with IBRsK. Rosener explained that the group was focusing on reviewing and revising the SAR. He added that the group name had been changed to better reflect the scope of their work.

Other High priority projects were discussed next:

a. 2022-04 – EMT Modeling

C. Fritz provided an update on the progress of the project, explaining that the SAR was currently out for comment. Developing a project timeline was the next step. J. Calderon confirmed that while this project had ties to the Order 901 Milestone 3 projects, it was currently a medium-priority project.

- b. 2022-03 Energy Assurance with Energy-Constrained Resources
   T. Pyle informed the group that the language had been presented to the Board in December and could now be archived.
- c. 2024-01 Rules of Procedure Definitions Alignment (Generator Owner and Generator Operator)
   T. Pyle explained that the DT would be requesting authorization to draft definitions during the January SC meeting, with a goal of posting in the first quarter of 2025. The group was also considering outreach in preparation of the posting.
- d. 2024-02 Planning Energy Assurance
  C. Yeung shared that the group had paused work as the Section 321.5 activities for 2024-03 had taken priority. Activities were expected to resume in the next week.

#### 3. PMOS Related Items

a. The PMOS action items were reviewed. There were no outstanding action items from the previous meeting.

b. Postings

M. Brytowski reviewed the Projected Posting Schedule with the group, noting that posting frequency would be increasing soon. PMOS Liaisons were encouraged to focus on communication with their DTs and the PMOS group to help ensure things proceeded smoothly. A. Oswald confirmed that medium-priority projects would be allowed to conduct formal postings in the first quarter of 2025, and low-priority projects may conduct informal postings. This would be reevaluated at least on a quarterly basis, or as new projects were added.

c. Workload

M. Brytowski also encouraged any Liaisons that needed to reevaluate their obligations to PMOS activities to reach out.
