


# Standing Committees Coordinating Group (SCCG) Quarterly Report

## **Reliability Issues Steering Committee (RISC)**

**Purpose:** The RISC is an advisory committee that triages and provides frontend, high-level leadership and accountability for nominated issues of strategic importance to bulk power system reliability.

#### **Top Priorities for SCCG Discussion:**

We will identify new risk profiles and begin prioritization this year. This will flow into the strategic planning with the RSTC work plans.

#### Recent Risk Identification, Mitigation, Monitoring Activity

- The Leadership Summit will take place on January 25<sup>th</sup>.
- The RISC will meet immediately following the summit to discuss new risks and begin the process for drafting the priorities report that will be presented to the Board in August.

# Upcoming Risk Identification, Mitigation, Monitoring Activity

- RISC will collaborate with RSTC
- Smaller teams are beginning to meet with NERC staff drafting the risk priorities report.

- RSTC- As the priorities report is drafted, input will be needed from the RSTC.
- Feedback loops that need to commence as part of the risk framework will be triggered as needed.



### Reliability and Security Technical Committee (RSTC)

**Purpose:** The RSTC strives to advance the reliability and security of the BPS by creating a forum for ideas and interests to support the ERO's mission, and leveraging such expertise to identify solutions to study, mitigate, and/or eliminate emerging risks.

#### **Top Priorities for SCCG Discussion:**

- Continue to monitor progress on RSTC work plan
- Prioritize and incorporate RISC Report and Cold Weather Report recommendations into RSTC work plan
- Incorporate metrics into Reliability Guidelines

# Upcoming Risk Identification, Mitigation, Monitoring Activity

- Reliability/Security Guidelines (including effectiveness metrics) are due in March.
- RSTC Work Plan Summit will be January 31-February 2, 2023.
- Seek Board approval of RSTC Strategic Plan and begin implementation.
- RSTC Leadership to participate in development of RISC Report.

- CCC Participate in the SCTF as needed.
- PCGC N/A
- RISC Evaluated RISC Report recommendations for risk mitigation activities by the RSTC subgroups. Will continue to monitor work plan progress and reassess progress in early 2023 and will participate in the RISC Summit January 2023.
- SC SPIDERWG has proposed two SARs on FAC-001 and FAC-002. The RSTC is in the process of reviewing these and will provide feedback to SPIDERWG. It is anticipated that the revised SARs will be brought to the RSTC in March for endorsement. For the TOCC Field Test plan, we will continue coordination of the field test with the Standard Drafting Team.



## **Standards Committee (SC)**

**Purpose:** The SC oversees the development of NERC Reliability Standards as its members review actions to ensure the standards development process is being followed.

#### **Top Priorities for SCCG Discussion:**

- Standards Process Improvements, recommendations for SCCG, RSTC and SC
- SC will partner with NERC Staff and consult with the SCCG to effectively prioritize standards development projects based on reliability risk.

#### Recent Risk Identification, Mitigation, Monitoring Activity

- Approved the 2023-2025 Strategic Work Plan.
- Standards Processes Manual and NERC Rules of Procedure posted for formal comment period.
