The comments/concerns were identified but not limited to as following: define thresholds; specify what kind of Faults should be studied; bullets vs. numbers in Parts R3.3 & R3.4; loss of communication and Protection Systems for proximate stations; etc.
- b. Based on the comments, the drafting team modified Requirement R3 to clarify acceptable/unacceptable thresholds by adding "technically justified". Technical Rationale document explained what it means for technically justified. Bullets were replace by numbering. Requirement R3, Part R3.5 were added for proximate stations.
- c. The drafting team stopped on page 125 of the comment form.
