## **Review NERC Antitrust Compliance Guidelines and Public Announcement**

Jason Snider, NERC staff, called attention to the NERC Antitrust Compliance Guidelines and the public meeting notice.

### **Roll Call and Determination of Quorum**

A team roll call was taken and quorum was determined. The member attendance sheet is attached as attachment 1.

### **Opening Remarks**

M. Hyatt, chair, welcomed everyone to the meeting, explaining that the group would continue its review of the existing CIP standards, flagging areas that will need consideration as the group develops language.

### Information Review

The group began with a review of CIP-008, presented by J. Sykes. Discussion focused primarily on what responsibilities, if any, would the cloud provider have in the registered entity's Incident Response plan. Could an entity simply refer to the CSP's plan? The group also considered whether language changes were necessary, or if cloud usage were better addressed through implementation plans.

J. Sykes continued to CIP-009. It was noted that the scale of the outage (would this include a cloud outage?) would need to be considered when implementing cloud usage. The group discussed shared responsibility – perhaps involving recovery time metrics to implement, and how to include the CSP's recovery plan into the Registered Entity's plan.

With the remaining time, the group reviewed CIP-012 together. The focal point of discussion was the definition of a Control Center, and if it would need to be modified regarding cloud usage.
