#### **Review NERC Antitrust Compliance Guidelines and Public Announcement**

Jason Snider, NERC staff, called attention to the NERC Antitrust Compliance Guidelines and the public meeting notice.

#### **Opening Remarks**

#### SAR revisions – final review

The group conducted a final review of the SAR, checking for editorial errors and confirming the team agreed with the final document. Minor revisions were made, mostly focusing on improving clarity. A roll call vote was taken to approve the document, and all drafting team members present voted affirmatively.

#### SAR Comment Responses - review and revision

The group resumed a review of the draft responses to the <u>comments received</u> on the SAR. L. Hale shared a response developed to address two comments received on Question 2 regarding "private cloud" use. The response explained that since the group was planning to use the NIST definition of "cloud computing", both "private cloud" and "on-premises cloud" configurations would fall into the scope of the SAR.

J. Snider explained that he pasted the responses developed by theme for Question 3 into the fitting comments on the Consideration of Comments form. M. Hyatt suggested that the group review these a final time over the week and send any comments to J. Snider by EOB 11/22/24. The group would vote via email to approve the finalized comment responses, with an email being sent to the group on 11/25/24.
