Proposed Path forward:

Review Standards that are currently enforceable to determine classifying them into the following buckets in Phase 1.

Phase 1

Bucket 1: Review entire Applicability section for inclusion, specifically to GO/GOP and identifying BES-related exclusionary language (e.g., BES, Facilities, etc.), that have explicit or implicit references to the BES or BES elements that would exclude the applicability of IBR.

Bucket 2: Review Requirements section for inclusion, specifically to GO/GOP and identifying BESrelated exclusionary language (e.g., BES, Facilities, etc.), that have explicit or implicit references to the BES or BES elements that would exclude the applicability of IBR.

Bucket 3: Review Standards that are not included in the Bucket 1 or Bucket 2, but are applicable to Cat 2 GO/GOP.

Phase 2

Standards that do not include GO/GOP in Applicability section, but where GO/GOP is referenced in the requirements (ex. VAR-001-5 where communication is needed between the TOP to the GO/GOP).

**Future standard (CIP-002 for example) not being addressed in this implementation plan.

**Possibility of sending out multiple implementation plans - Bucket 1 and Bucket 2 go into one implementation plan.
