### 1. Complete SAR revisions

NERC to provide this analysis during the drafting stage of the implementation plan.

The drafting team will be asking the Standards Committee to authorize the drafting revisions of the Generator Owner and Generator Operator definitions at the November 13 Standards Committee meeting.



# 2. Begin GO - GOP Definition revisions

The drafting team began to review the revisions for the Generator Operator and Generator Owner definitions in the Glossary of Terms. The team asked for the Rules of Procedure definition for IBR. The team will review the approved definition for IBR along with the <a href="IBR ROP Compliance Filing">IBR ROP Compliance Filing (nerc.com)</a> to aid in the revision of the GO and GOP definitions. The team will continue to review definition revisions during the drafting team meeting on October 10.
