### 1. GO GOP Definition revisions

The drafting team discussed options for approaching revising the definitions.

- 1. Proceed on the path of defining only GO and GOP as outlined by the SAR
- 2. Define generation to be used inside the definition of GO and GOP The majority voted to proceed with option 1.

The drafting team was split into two groups to review the GO and GOP definitions. Sub Team 1 (GOP definition): Kristina, David, Libin, John, Steve, and Bobbi Sub Team 2 (GO Definition): Dane, Colten, Libin, Todd, Steve, and Matthew



The drafting team voted to proceed with the GOP definition using the ROP approved definition and incorporating the Board approved capital IBR definition (not yet FERC approved) where appropriate, and make tweaks to ensure it fits.

The implementation plan was not discussed during this meeting and will be placed on future meeting agendas for discussion after the definition revisions are completed.

The team voted to keep pre-discussed redline revisions to the SAR and not add the language in red.

The SAR revisions have been finalized. The team will seek authorization to proceed with draft revisions at the November 13 Standards Committee meeting.
