- a. Nitika Mago, ERCOT, project observer presented a slide deck to add to the CLR definition discussion from the April 26, 2022 meeting.
 - o The SDT discussed inputs from Nitika Mago, ERCOT:
 - ERCOT appreciates that the SDT is considering to use two years of data as a criterion for establishing CLR;
 - With the proposed changes in process for computing FRO, an interconnection’s FRO will be primarily reacting to changes in CLR;
 - ERCOT is in the process of changes to its ancillary service program;
 - ERCOT anticipates that the anticipated changes will influence how Load resources with under-frequency relays participate and provide Ancillary Services in Real-time.
 - o ERCOT would suggest that the request that the SDT consider giving entities the option to provide a data sample larger than two years.
 - o Entities may use this option when the two year history is not a reflection of Load resource availability that can be expected in the upcoming operating year.
- b. Agenda Item Number 3: Structuring of language for the Reliability Standard to address Section 1600 data request was not presented due to time constraints. This agenda item will be added to a subsequent meeting agenda.
