- a. Team leads provided updates from their respective subgroups.
- b. NERC management went over the standards development process.
- c. DT started discussions around the predefined criteria. DT members asked is load-shedding was appropriate solution and if there should be some flexibility to allow entities to determine their own predetermined criteria. It was noted that for the operations time horizon, the DT believed that every hour of the day should be analyzed. Therefore, the DT agreed to an hourly assessment. It was asked how to model demand and how to coordinate studies amongst BA's. DT believed that a deterministic approach would be the best approach.

3. Discussion on May 10, 2023

a. DT resumed discussions and started drafting standard language. There was a discussion about the solution to address risks observed from the assessments in the operations time horizon. The options of Operating Plans or Corrective action plans were debated.

4. Next Steps

a. DT to conduct research into the appropriate options for corrective actions. DT decided to have weekly meetings and to meet in-person quarterly.
