2. Discussion

- a. The manager of Standards Development provided details about the results of the initial posting.
- b. SDT worked on the Planning Draft. The first topic of discussion were around R1 which is the RP setting up ERA and studies. One question that was proposed Is the Resource Planner the correct entity to perform ERAs. Planning Coordinator was mentioned as an additional responsible entity for documenting and performing ERAs along with the Resource Planner. It was noted that not all entities are registered as the RP and PC. Additionally, there was a proposal to add language around allowing the RP and PC to decide who should be responsible. Also, there was a discussion about regional flexibility and allowing entities to determine how they perform their assessments.
- c. SDT reviewed R5 all were in agreement to the language as is.
- d. SDT reviewed CAP language in R7. Discussions were about the structure of the proposed language. Examples of EOP-012 CAP language was mentioned as a way to construct the language.

e. Action Item Review

a. SDT will need to finish Q2 and start on Q3 in tomorrow's meeting.
