1. Introductions

The meeting was brought to order by the Chair, David Mulcahy at 9:11 a.m. Eastern. The Chair provided the Drafting Team (DT) with opening remarks and welcomed members and guests.

2. Determination of Quorum

2. Discussion on March 5, 2024

- a. Discussions around applicable entity for the planning time horizon energy reliability assessment. Some believed that the Resource Planner (RP) alone was the right entity to hold responsible for the requirements while others believed that Planning Coordinator (PC) was the more appropriate entity. There was concern expressed about how the RP would receive the data needed to perform the studies as there aren't any current standards that allow the RP to get the data, however, in MOD-032, the PC and Transmission Planner (TP) already have access to this data. Team voted that the RP should be the responsible entity.
- b. Additionally, there were discussions about conducting assessments after year six. It was mentioned that data needed to conduct studies that far in advance would be best guesses and that there was not much an entity could do to resolve issues.

3. Discussion on March 6, 2024

- a. Discussion continued with finalizing parameters for when an RP can conduct their study. TPL-001 was mentioned as TP and PC gets three options on when they can perform their studies.
 DT decided that allowing an entity to choose between three options:
 - i. One two years
 - ii. At the five year mark
 - iii. Pick between six 10 year

4. Discussion on March 7, 2024

a. Discussions were around mitigating options if energy deficiencies were found during the analysis. It was noted that Corrective Action Plan(s) were the best option for the longer lead times. There were some DT members that were not comfortable with having a CAP as a mitigating measure. Additionally, DT members proposed alternative language to all to consider.

5. Next Steps

a. Developer proposed to have a side meeting with the planners on the DT to receive specific feedback to the proposal as many of the DT did not support the version that was drafted at the conclusion of the meeting.

The meeting adjourned at 12:45 p.m. Eastern by consent.
