- c. There was a suggestion that after the first sentence in 6.2, add "NERC shall receive, review, evaluate and respond to the extension request in a timely manner. Accepted extension requests shall follow the schedule in the request. Rejected extension requests shall be granted an extension duration equivalent in time to the period from NERC's receipt until its subsequent response". Extension requests will be received and evaluated in accordance with the NERC process issued concurrently with this standard. For Generator Cold Weather Constraints determined as required for generating unit(s) upon beginning commercial operation, submit the Generator Cold Weather Constraint declaration(s) within 15 days of commercial operations.
