Introduction and Chair's Remarks

The meeting started at 12:00 p.m. Eastern.

NERC Antitrust Compliance Guidelines and Public Announcement

The NERC Antitrust Compliance Guidelines, NERC Participant Conduct Policy, and the Public Announcement were presented and reviewed by the secretary.

Agenda Items

1. Introduction

- a. The Vice Chair welcomed the Drafting Team (DT) members and the participants from the industry. See **Attachment 1** for those in attendance.

2. Develop Draft of Standard, Implementation Plan, VRFs and VSLs

- a. The drafting team continued to review the rest of the comments received from the Quality Review Team on the Standard. Then continued with the Implementation Plan.
- b. FERC staff reminded the drafting team that in the Attachment 1, Case-by-case Determinations of Generator Cold Weather Constraints, the drafting team/NERC should provide justification on the 3% used on the application of freeze protection measures would reduce the generating unit's ability to provide Real Power or Reactive Power. FERC staff also brought up on the "denial" of CAPs. The drafting team pointed out that this should be covered by IRO-010 and TOP-003 Standards.
- c. Net Dependable Capacity (NDC) was used in the Standard and footnote. Since it is not a defined term in the NERC Glossary of Terms, this was introduced in the Standard as lower cases.
- d. The drafting team finished reviewing the comments received from the Quality Review Team. The final draft of the Standard and associated Implementation Plan will be submitted to the Standards Committee for reviewing and approval for initial posting.
- e. Ben W. reminded the team member to register for the in person meeting in November. The in person meeting announcement already went out.



f. The drafting team discussed the Technical Conference. Such as what the agenda should look like, who should be on the panel, and what topics should be presented at the conference, etc.
