STANDARDS NEWS

NEW Standards Committee Special Election for Segments 2 and 8

Due to a recent vacancy for Segment 2 and the vacancy for Segment 8 from the last term election, there will be another election held to fill the remaining two-year terms (2025-2026) for each of the two segments. When submitting a nomination form, indicate the segment you are interested in for membership.

Registered Ballot Body (RBB) members and others interested in NERC Reliability Standards are encouraged to submit nominations for industry segment representatives on the SC. Reliability Standards are mandatory for all bulk power system owners, operators, and users in North America, and the SC's oversight role is therefore increasingly important. The SC consists of two members from each of the 10 Industry Segments that make up the Registered Ballot Body. In addition, Appendix 3B of the Rules of Procedure contains special provisions to be used to achieve a balance of representation between the United States and Canada. The SC is elected by industry stakeholders and reports directly to the NERC Board of Trustees. The SC meets up to 12 times each year, with four face-to-face meetings and the remainder by conference call. The [Standards Committee Charter](#) provides a description of the SC's responsibilities.

To be eligible for nomination, a nominee shall be an employee or agent of an entity registered in the applicable Segment. To allow verification of affiliation, a nominee must be a registered user in the NERC [Registered Ballot Body](#). It is not required that the nominee be the same person as the entity's Registered Ballot Body representative for the applicable Segment. Instructions are provided in the [Election of Members of the NERC Standards Committee Procedure](#), and nomination forms are posted on the [Standards Committee Election web page](#). Please find the [Nomination Form](#) on Survey Monkey. All nomination forms must be submitted no later than **March 18, 2025**. Once received, nominations will be posted on the [SC Nominations and Election web page](#). The election will be held from March 31, 2025 to April 9, 2025. Election results will be announced shortly after the election closes. Questions may be addressed to [Dominique Love](#).

NEW ERO Enterprise Endorsement Withdrawal

On March 12, 2025, the ERO Enterprise withdrew its endorsement of the CIP-014-2, R1 Transmission System Risk Assessment (NATF) Implementation Guidance. Please see the Non-Endorsed Implementation Guidance Spreadsheet at [Compliance Guidance](#) for additional information.

ERO Enterprise endorsement of Implementation Guidance provides assurance to industry stakeholders that they may rely on the guidance for examples that support compliance with NERC Reliability Standards. ERO Enterprise endorsement may not be granted when it is determined guidance changes the scope of a Reliability Standard requirement. Upon review, the ERO Enterprise determined that the NATF Guidance as currently written changes the scope of the requirements in CIP-014-2 by indicating that stability studies are optional, even though stability studies are required by the standard.
